Burial Ground Fees

The following fees shall be effective from 1 April 2025

1. Purchase of Grave plot for a resident within the Parish

Purchase of Burial Grave at time of Interment

£400.00

NB. A burial grave plot for interment may only be purchased for the burial of a deceased resident of the parish or for a deceased person who otherwise had a close association with the parish at the time of death. At the time of that purchase or within 1 Calendar month thereafter they may pre-purchase, if available, an adjacent burial plot for interment for the future use of a resident of the parish or for a person who otherwise has a close association* with the parish. (*Close association is to be taken as partner, parent or child).

Purchase of Cremated Remains plot

1.	Purchase of a cremated remains plot for a resident within the Parish (as required)	£200.00
2.	Purchase of cremated remains plot for a non-resident of Parish (as required)	£375.00

Interments to Graves

1.	To ordinary grave for a deceased resident within the Parish	£350.00			
2.	To ordinary grave of a deceased person who resided outside the Parish	£800.00			
	(generally for those with pre-purchased grave plots – seek clarification if in doubt)				

3. To ordinary grave for a deceased resident under the age of 16 years within Parish - No Charge

Interment of Cremated Remains

1.	To ordinary cremated remains plot for a deceased resident within the Parish	£160.00
2.	To ordinary cremated remains plot of a non-resident of Parish	£375.00

3 To ordinary cremated remains plot for a deceased resident under the age of 16yrs. No Charge
